Madame Chair just wanted to report to you and the Board that the HUD CHOICE implementation site visit is scheduled for March 6th and we've been meeting with the internal team and the partners and we are pretty much prepared for that meeting. As we have indicated in the past this meeting will be a working meeting. They've given us a partial grant and not the full 30 million dollars. We will present what we have in mind and then they will discuss it with us and take it back to their offices and mull it over some more and let us know what they will decide to do and what directive and direction they will give us. As you remember from the press conference Dominique Bloom indicated that the 13 million is for the Branch Village development and the other projects that we had in mind will have to put those on hold. The city council has also requested I make a presentation on behalf of the Housing Authority. They want to see some financial reports and an update as to where the Housing Authority is presently and so that is scheduled for their caucus meeting. We continue to move forward with the RAD program and recently we met with the affected residents and the union leadership. So we're moving ahead with RAD here at McGuire and also Baldwin's Run II.

Before we begin the public participation I just wanted to Victor D. Figueroa:

announce again that there is a three minute time limit. Any responses to your questions will be put in writing so there's no answers given tonight but you will get a response in writing at a later time. The first participant is Ms. Laverne

Williams.

Laverne Williams:

218 Branch Village. I still have a problem with your utility allowance of \$38 for one bedroom. As I said my rent went up. I'd like to know what figures you use to identify \$38 for one bedroom, \$46 for two bedrooms and \$54 for three bedrooms. After I do my homework you're going to owe me money because my rent went up. My next concern is that McGuire was having problems with the RAD program. I'm concerned.

Victor D. Figueroa:

Let me just clarify it's not all sites. It's Branch Village, McGuire and Baldwin's Run II.

Laverne Williams:

And I have another concern about I need to know you got \$13 million from HUD. I'd like to know what part of that \$13 million will be used for Branch Village. Is it for the Midrise or what? How much money did you get for relocation?

Victor D. Figueroa:

None of the Choice funds are going for Branch. The money is coming from tax credits and RAD.

Laverne Williams:

Ok. You have to put that in writing for me so I know what's going on because you can't have me blind here in the City of Camden.

Victor D. Figueroa:

Thank you Ms. Williams. Next participant is Ms. Maynard Hall.

Maynard Hall:

202 Raritan Street. I have had the opportunity to live in Chelton Terrace, Roosevelt Manor and McGuire and I must say that I came into this meeting blind. I hope you take into consideration that when you're building reconstructing the new building, especially if they are for seniors, because I live in what is considered a senior apartment and it's attached to four family homes....the children have to laugh and play but at the same time it's like I'm laying in their laps because you can hear everything that's going on. I thought they had a monkey the other day. The main thing is that why nobody shows up at these meetings because it's not serious to them. Until something bad happens then they want to start speaking up. A lot of our residents do not understand English. There needs to be a meeting held in just Spanish for them, seriously because the RAD meeting was a disaster. People went outside and still nobody still understood what was going on. The office is no help! For example I call that they pouring grease in the drain and they hang up on you. It's like we're babysitting you all. Except when it's about

the rent and then it's the residents fault. The communication has to start somewhere. Not just catch you by the coat now. This is about people's lives you just can't get a place to live no more. We want to be able to take care of what we have properly and feel safe and enforce the rules! Like the trash on the sidewalk, come on now all you care about is the rent. Wait a minute. You just look at us like low income. I just hope moving forward that you all are designing these places.

Victor D. Figueroa:

Ms. Hall your time is up. Just for the record you said that the RAD meetings were held that we translated throughout the course of the meeting. We're going to respond to you in writing. For the RAD we are not going to be doing new construction we are just going to be replacing the old systems and upgrading. We are going to be putting \$5million in the first year once we implement the RAD. The next individual Ms. McDave.

Rosita McDade:

2024 Jones Street. I want to know are you'll going to still make us pay water or you going to surprise us. What's going on with that?

Victor D. Figueroa:

We're going to do it in writing as well, but based on the meeting that we had yesterday with the resident leadership that included three of the resident board members. Basically the landlord will be paying the water and sewer. The residents will be responsible for utilities.

Rosita McDade:

We got a notice in the door today they said the 24th they are going to pick certain units and they going to go there. I want to know what they are doing?

Victor D. Figueroa:

That's a physical needs assessment that was done previously and they are following up with vacant units and a certain amount of occupied units. If you received a letter your unit will be inspected. If you didn't receive a letter your unit will not be inspected. That's just for the RAD reinspection not the REAC inspection. So there's two different inspections in the next two weeks.

Donna Moye:

2311 Jones Street. I was about to ask the same question she was asking. First I don't understand, we have a bunch of units empty here in McGuire Gardens Apts. because people moving in and out, but also you have to remember that you are bringing people from other sites that are relocating. You also have people in two bedrooms that need to be in three bedrooms and people not supposed to be

in two bedrooms that need to be in a one bedroom. How come that you can assess the needs of McGuire residents first by moving the people that have a lot of children into the apt. size that they need before you start moving other people into the development. It's not right. People have been waiting a long time for extra space. Some people have 10 year old daughters in the room with 12 year of sons. Another thing that I don't like you'll doing a lot of inspections. You already know what we need out here. You know what needs to be done. Yet you just saying if you received the paper they are coming.

Victor D. Figueroa:

We are talking about two different inspections. The RAD inspection if you received a letter they are coming to your unit. If it's a REAC inspection everyone is going to get a letter because a REAC inspector which is a third party HUD inspector and they randomly select the unit the day of the inspection.

Donna Moye:

The one we got is for this Friday. Also housing did an inspection for the maintenance guys to come out and check for smoke detectors which they had two days to do, which half of the development wasn't even done. So we still haven't got another letter from that since. So is that a priority before you'll coming. What's going on? Because you'll just running in and out of people's houses. This is really getting on my nerves. What are you looking for? You already know what needs to be done. I need painting, I'm not going to keep washing no walls. I've been here since 1999. We have Pathmark and Kmart floors. The marks is bad. They need to be buffed. The siding is filthy! Instead of someone being for all developments. You got to stop doing for differently for different developments. Please start sending flyers when there is Commissioner meetings because people don't know. We have had a lot of break ins lately.

Victor D. Figueroa:

Your time is up.

Ebony Jennings:

163 Pfeiffer Street. I've been out here for eight years. Within eight years I have not had my apartment painted. I asked them to retile my bathroom, it has holes in it. It's still not done. I had a flood from my bathroom to my kitchen and it's still not fixed. I have three boys and a girl and we still live in a two bedroom. My kids like being outside, we have the Camden Police Department because all the shooting and people selling drugs. I pay for where I stay, it may not be a lot but it's my sanctuary. My kids

should feel safe when they go to bed at night, when they are out in the backyard. I shouldn't have to run to the yard to get my kids because can't understand and get along with other people. That is not right and when you ask for help from the complex - oh we don't do paint jobs. It takes a couple months to finish a tub. I even had someone from the office tell me that it wasn't their fault that I had four children. I respect everybody. How you get here is your business. I was told to make a living room a bedroom. Also, I don't know if they are putting out stuff to feed roaches but I have to keep the lights on at night and spray Raid through my house. I don't like complaining but this is my option for now until I can do and be better. All I want to do is take care of my kids and be safe. I don't want to take my kids to my mom's house to have a bath. They write it down, but they don't get it done. I don't know why they don't assist me. I make sure I pay the rent. I make sure my kids respect others. I have to tell young men to get off my front steps and stop selling drugs. The police show up and I say you are allowing them to sell drugs on my steps. Somebody needs to protect me and mine.

Victor D. Figueroa:

Your time is up. For all the participants we will be following up with all your concerns in writing.

Commissioner Person-Polk:

We will definitely follow up with responses to your questions and the necessary repairs that need to take place in this facility. I'm not really a happy camper right now. So it's going to be done and we are looking at putting additional camera's out here. So your President is here and I'm hoping she took notes so when they have the meeting with the developer and the management about the lighting and the cameras out there.

Ella Baker:

156 Pfeifer Street. President of McGuire Gardens. The things that they did mention today I didn't have to take notes because it was brought to the attention of the Housing Authority. The complaints that I showed you.

Commissioner Person-Polk:

Yes. I think I was a little bit upset because we had a meeting the other day that was very productive with the Executive Director and Deputy Executive Director and Tracie and with the Resident Council. You should be seeing a difference. I thought that was in addition to what we had yesterday. We did take care of one thing yesterday. We're going to get it done. You have to work with us. I want the young lady to know that we will be putting up cameras to help with that kind of activity that is beyond her

control. Thank you for your patience. Now we are going to go into closed. When we come back out of closed we'll still have a public session if you'd like to hang around.

Commissioner Gibson: What's its purpose?

Edith Pagan: It is to build up women and come together and talk about

any issues that may be occurring and to encourage women.

Commissioner Gibson: So I can come and join?

Edith Pagan: Yes you can.

Victor D. Figueroa:

I just want to comment on my report. It's been a whirlwind the past two weeks. I traveled to Washington D.C. to the National NAHRO conference and a lot was said about the Americas First Blueprint budget. Secretary Carson gave some comments and basically what we've been hearing the doom and gloom. We have to prepare for whatever may come down the pike. He's saying it's just a blueprint and hopefully things will get a little better. We're just trying to do our best to prepare for that. On March 24th we had a mass meeting with all staff. We kind of expressed that to them as well. Basically we have a \$54billion cut which \$12.2billion of that will be cut from HUD. We have to run a little leaner and everybody has to take responsibility for what their role is and their functions. We had some feedback from staff and I think everyone understands that they have to do their responsibilities. We also discussed at the last Board meeting that we are facing a \$500million cut in the budget this year. It's a little bleak but we're trying to see what we can do to run as smooth as possible and that's why we are creating the LLC's and Watson Street non-profit. We are trying to reinvent ourselves to find different and new revenue streams. That's why we brought staff onboard. We're going after other grants - any other national grant that we are eligible to apply for either as the housing authority or through our instrumentalities. I also went to NJ NAHRO and it was basically the same message. So we're out there listening, trying to see what we can do at the local level to at least improve our chances of surviving 2-5 years. I also wanted to let the commissioners know that we went to City Council last night for some of the projects that we are working with the RAD project at Branch Village as well as McGuire. There were some questions raised about rateables. Just for

the record as far as the City is concerned- they are complaining about us bringing in businesses and giving them tax abatement or tax breaks. But if we don't bring services and jobs to the City residents aren't going to come to live in the City and then we won't be able to impose real estate taxes on empty vacant homes. We need to entice folks to come and live in the City of Camden so hopefully we can continue to drive that message so we can continue to make Camden a better place to live. Also tomorrow night we have a planning board meeting that we have to attend. City Council passed all the ordinances that we presented. Last but not least I wanted to tell Commissioner Gibson we're expressing our condolences on the loss of your daughter and we've presented a resolution to you and your family.

Commissioner Person-Polk:

I want to add a couple of comments. I did attend the funeral service. This young lady, Ms. Gibson's daughter was a special person. She helped my son years ago to pass the SAT test to get into college. You don't realize how many people she impacted. She played the piano at 18 churches and she wrote her own obituary. It was a beautiful thing. We love you and we're here for you.

Commissioner Gibson:

I want to thank everybody for what they did, all your prayers of support, your cards, and your love. I really appreciate it. Also I want to thank YouthBuild for giving the youth in the City of Camden a place to see something outside of the City streets of Camden. Thank you so much.

Commissioner Person-Polk:

We had a retreat and one of the things that we had promised HUD almost a year ago was to use the tool "lead the way" to train commissioners. Because it's not just good for one commissioner to know...all of our commissioners need to know. The retreat was excellent. It gave us an opportunity to interact with each other and we are also looking forward to part 2. We're also looking forward to—managers we are letting you know that a lot of the commissioners have not been at your sites- a tour for all the commissioners to go to the sites and visit them. We want to go to the manager's offices. So be ready we're on our way.

I'd like to introduce Ms. Edith Pagan, Director of Resident Initiatives and I'd like to introduce Tracie Herrick, Director of Section 8. And while we're standing up here when we see Ms. Laverne Williams we want to say that I personally known you for 100 years. I just want us to know the horrifying situation that she was in. I'm not going to spread her business. I know that every staff that we reached out- Ms. Laverne need this...Ms. Laverne need that...we were there to try to support her and just want to say that what happened to you should never happen to anybody. We want to acknowledge you tonight and basically say that you are one of my heroes now because you endured. The pain and stuff that you done went through. I also want to say that Ms. Laverne has been an advocate for public housing for over 30 years. She has fought to bring a lot of changes in public housing. Thank God there is a Laverne because if you don't have advocates like her a lot of things are overlooked. She's always been on top of the Housing Authority and the residents. Anything that you need us to do I'm willing to do whatever you need me to do. I want Tracie to talk because one of the process we had to take was that Resident Initiatives badgered her to move but we feared for her safety. This was serious we had to get up out of that situation. I'm not saying she was very cooperative but she went on and she allowed us to move her. Everyone was calling us. They was on us but they didn't have to be on us because we love her. We called Tracie and Tracie department picked it up and helped her with her paperwork.

Tracie Herrick:

We finally got you with us at Section 8 which we were trying really hard to do. We're going to take real good care of you until such time where we can deliver you safely back to Branch Village when rebuilt. We also need to give a shout out to Pennrose who moved very quickly to help us relocate you. (inaudible)

Commissioner Person-Polk:

Yeah come on up.

Laverne Williams:

I want to thank everyone. I got hurt on February 27. This guy above punched me hard and I'm lucky to be here because I could have died. Blood came out of my nose and my nose is still broken. My issue here with the Housing Authority is like we have complaints with tenants you need to do something about them as soon as possible. All the people living in the apartment not on the lease should be out of there. They are causing problems with tenants who've been there for years. I been out there since 1970 and had nobody ever hit me. I messed with drug dealers and they never attacked me. This guy don't even know me at all. But the issue is that the people came to my aid; city council, the municipal clerk, Malcom, Norman. You all didn't want me to go back to my unit.

Commissioner Person-Polk:

All the Commissioners were in support of all of it because we did not want you to get hurt again and we wanted you to be safe. Everybody was on board as soon as we found out about it. A lot of times people complain about the staff and they say negative things, but when the rubber has to meet the road they are right there. You know now that you are dealing with a whole new breed. Years ago young people had respect for adults. Years ago they respected the women more than the men. You could get away with saying something to them.

Laverne Williams:

I'm still trying to get my way.... I'm still strong, but I know I have to be careful.

Commissioner Person-Polk:

You are a senior citizen and you're not that young person anymore. Even though it's in your mind because I'm the same way. You have to be careful. Right. We do care

about you. We were given reports until everything was done.

Laverne Williams:

Alright thank you for everything. Thank you for your prayers. I'm still here. I'm still raising a little bit of cain. I still got that fight in me.

I'm glad to see you smiling and you do look good.

I get tired sitting in that house. It's so quiet I'm about to go crazy.

Commissioner Person-Polk:

We're going to change the order of the meeting because I see quite a few people. We'll have public participation before we go into Closed and then we'll have one after we come out of Closed. So if you put your name on the list and you would like to speak. We are going to allow you to do so at this time. Cynthia Hannah

Cynthia Hannah:

Good evening to everybody. First of all I would like to say that we are trying to work with you guys, we really are. Things are not going the way they are supposed to go and what I mean by that is we do not have a Social Services Coordinator. There is a lot of social services ills out here. I was told in February when we had that meeting with the Executive Director that that was going to be done and Victorit hasn't been done. There's a lot of shootings going on out here when you begin to mix people from other developments. The crips and the bloods, I was appalled that nobody from the Camden Housing Authority contacted our Board to find some kind of measure that we can take with this public safety. They had a party out here.. I don't know if it was the Crips or the Bloods but they had a shooting out here and they said that family had come from Branch Village. I don't know how true that is but we have to work together. I'm tired of promises. Second of all what I want to know is when these contracts going to go in for the grass. They have bushes taller than me and that's not a joke. There's bushes by my house that's almost up to my windows. Then I heard that you all don't have a contract with that. We have a lot of vacancies out here. I was appalled at the low score that we got from the REAC. We usually carry the Housing Authority, we got a very low score and that didn't sit well with me because I am a resident and I do care. This is my community. You all go home at 5 o'clock but when you live here like we live here after 5 o'clock you don't see it. We don't need a safety director from 8 to 4. We need somebody here from 4 on because that's when it gets to poppin. Now I don't want no promises. I came here for some answers. Victor I've been trying to get a hold of you and every time you don't want to take my calls so I want to know what's the problem.

Victor D. Figueroa:

Well you know that's not true.

Cynthia Hannah:

I called about a family and I was told that Victor is not handling it he sent it to Asset Management. That really hurt my feelings because I thought we were bigger than this. We're trying to work with you guys, we really are. We didn't come here to down you guys but we are tired of the promises.

Victor D. Figueroa:

I did inform you that if you're going to talk about another resident we have to get specific...

Cynthia Hannah:

No it wasn't about another resident it was about what's happening out here with the shootings at night. That's what I called you for. I didn't call you on behalf of another resident. I called you on my safety and my residents' safety. So like I said before we had meetings with City Council on you all. We're not trying to be the bad guys, we're trying to be fair. Don't tell me you going to look into it and don't look into it. Let's work together. Thank you.

Donna Moye:

2311 Jones Street. I aint going to holler at you all today. I'm tired of hollering. Today I'm going to exercise my rights as a resident. ...where you are in violation. It says here the landlord must keep, but you all are above that. Many times we come to this meeting talk to you all and it's always about what management is not doing and I'm sick and tired of coming here behind the fact of what you all not doing. It's really getting on my nerves. I have a right. It says the landlord must keep the property in good repairs and clean free of infestation and free of any hazardous nonsense that might be harmful to the health and safety of the occupants which is the residents....which Ms. Blondie was talking about the grass. Verbally does not mean anything a paper trail, it means a whole lot and pictures means a whole lot. I have pictures here so that you can look at them. You all claim that you did a walk through a lot of these developments. I don't know what streets you went down because you sure didn't come through here. Over here the grass it up to my foot. You got seniors that live by themselves that have to bring trash out. If they trip and fall over the overgrown grass in the walkways you are responsible if something happens to them seniors. If any of them children are playing in the yard where the grass is up to their knees and there are foreign objects in that yard and they fall on it...you are responsible. Can I approach and show you the pictures?

Victor D. Figueroa:

While you are bring that up. I did mention earlier that we will be addressing that this evening.

Donna Moye:

You all claim that you went to a lot of properties that were

immaculate.

Commissioner Person-Polk:

We didn't say a lot. We took a tour and let's say we went

into some.

Donna Moye:

Ok. Some. You might have went to some that they wanted

you all to go to.

Commissioner Person-Polk:

We went inside some.

Donna Moye:

Why didn't you go into the ones that needed repairs? You are not doing a lot for McGuire. I don't have to live like this and nor do the residents. They can exercise their rights and hold their rents. It's not like that in other developments where the grass is all the way up to your knees. You all got some money find somebody and cut this grass. I'm tired of living like this. Come on man do what you all should be doing. Now you see the pictures. I will hold my rent. We will go to court and I will win my case. It's simple as that.

Victor D. Figueroa:

We have a resolution for a contractor to cut the grass that is

being presented this evening.

Donna Moye:

The people that you do have to cut the grass. Who are the overseers that supposed to be behind these guys that's cutting this grass? Because when they do here and across this street immaculate, but when it comes to our property where we live at. they ride right past up and down. High up here and low down here. Nobody is behind these guys watching them when they cut it. It's terrible. You all kicking out all this money for these people to cut the grass. Another thing these contractors when they are cutting this grass are they supposed to pick it up?

Commissioner Person-Polk:

Yeah

Donna Moye:

No they do not pick it up. They leave it right there turn brown and gray. Nobody is overseeing these people. Somebody better get behind these people that you all paying all this money for. I'm tired of having this up to my knees ... weeds all up against the trees. Fleas and ticks is out there. Somebody fall you all are responsible. I will hold my rent and put it in escrow. I will get me a lawyer and I will win. This is not a threat. Seriously you all overseeing us. Ever since you got back McGuire is looking just like it's going right back to where it was before. Please

do something. We're tired of waiting. The children need to go in their yards and play.

Victor D. Figueroa:

As I said already we're addressing this evening. We're going to get the contractor and they are going to start cutting the grass as soon as we say they can proceed.

Commissioner Person-Polk:

Ronelle Jones-Brown

Ronelle Jones-Brown:

Good evening. I am here inquiring in retrospect to my former position as social services coordinator for McGuire Gardens. I have been out on medical leave since July 2016 and I have written correspondence and phone calls to HR Alicia Williams. If anyone is not familiar with the forms they come from the State known as the P-30 form which is the form that keeps your employer informed of your progression of your medical disability as to reasons why you are out. I provided HR these forms and the key word is tentative. My primary physician provided that my tentative return date was January 16, 2016. The second P-30 that was received by HR was changed to March 2nd because at the time the first one was submitted the physician was unaware that I needed surgery at the time. I did receive the surgery.

Commissioner Person-Polk:

Excuse me. Would you like to have this conversation in Closed Session?

Ronelle Jones-Brown:

No my question is the letter I received from HR identifies that I was involuntary terminated and as a result for business purposes for HACC the position had to be filled. To the best of my knowledge as of this point it is still open and McGuire Gardens still does not have a Social Services Coordinator. I was informed that I could reapply. I have reapplied and I just would like to know what the status is. Does HUD provide a requirement for all HACC housing sites to have an Social Services Coordinator? Is that public or private?

Victor D. Figueroa:

No it's not a requirement.

Commissioner Person-Polk:

We were trying to ask you if you wanted to discuss it when we go in Closed Session.

Ronelle Jones-Brown:

That will be fine. Do I need to schedule a date with that?

Commissioner Person-Polk:

No, I believe we can do it this evening. We're getting ready to go into Closed Session as soon as the public is finished.

Ronelle Jones-Brown: No problem. Thank you.

Commissioner Person-Polk: Ella Baker

Ella Baker: 156 Pfeiffer Street. I just have an issue with management.

Basically I've been going to the south side to get copies. Now if I need copies that go out for Resident meetings or anything that I need copies for. I'm always having a problem with them so I go to the south side to avoid issues.

Commissioner Person-Polk: What is south side?

Ella Baker: Centerville. I go to Chelton Terrace to get my copies.

Victor D. Figueroa: To Resident Initiatives Department...is that where you go?

Ella Baker: Yes. I'm using my gas and my time when we have a copy

machine right here in the office. I also use a portion of our PUI funds so that we can have our own copy machine that will be able to higher demand on copies that we need. Which we could have use that money on something else.

Again I'm trying to avoid problems.

Victor D. Figueroa: Your printer doesn't make copies?

Ella Baker: Victor that little printer? It makes copies but if I'm trying to

make copies for 250 something residents I'll use one

cartridge doing that.

Commissioner Person-Polk: So do we have a copy machine?

Ella Baker: Yes in the management office.

Commissioner Person-Polk: So how often do you make copies?

Ella Baker: Not that often at all.

Commissioner Person-Polk: Right so I would think it would be cheaper for us to supply

the paper and let you use the copy machine than buy a

copier.

Ella Baker: That's what I thought. When I do go to the office to ask for

a copy I'm always getting an attitude.

Commissioner Person-Polk: Here's one thing that you have to understand in the office.

They run on their schedule and what they have to do. You

have to work out some kind of way, a day set aside for you

to make copies.

Ella Baker: I'm going to say this to you as well because I'm a workable

person. But if she couldn't do it for me right then and there I said "do you think you could get it done for me tomorrow?" "maybe" and it's always "maybe". Ok I'm

waiting another whole day and it's always maybe.

Right and you have to get them out. Commissioner Person-Polk:

Ella Baker: Exactly. I need somebody to work with me.

You'll get your landscaping done tomorrow. Right at McGuire. The contract was just approved. I would like to entertain public participation if you like. We just approved the contract for services and it does include maintenance. So you don't have to worry about the clippings being on the ground. Excuse me I have to leave and Ms. Gibson will take over at this time. She is the Vice-Chair and we do have a quorum.

Victor D. Figueroa:

Thank you Madame Chair.

Cynthia Jordan-Hannah:

My name is Cynthia Jordan-Hannah I reside at 82 Rand. I want to know about the PUI money. This year we had so many vacant units that we were reprimanded as the residents so that took a big chunk of the PUI money. Now I remember this and I also made a phone call and did my homework. That each empty unit you get from \$5-\$10 and I found out that we all together out here have 60 vacancies. My next question is also concerning the PUI money. Why do we have to take money out the PUI money that's for the residents and begin to pay salary for summer help? Can't you'll come into some agreement with the City of Camden and find out can they hire these people because if you're going to take our money that means that the residents are losing.

Malcom Isler:

So what I do know about PUI is that one it's not 60 vacancies here at McGuire. This year's PUI the money you received is not based off this physical year. It's based off of last year as of the closing of June 2016. Then the Resident Association we don't dictate the budget that you guys put together. It's up to the Association to put your budget together but I can say for the past years we have always if assistance was needed we have always worked with the City to get assistance to hire City workers to work inside the Community Centers. So if it's needed that is what we are going to do.

My next question is with the PUI money...our Board is new now I don't know what the previous Board did before we came aboard but we only got \$5,092 and some odd cents. That is hardly nothing. I also want to know what happened to the money that we raised out here by renting out the community center it's like \$7,000 so what happened to that money. We could certainly use it for activities out here. I've asked this question seven times and no one has responded back to me and I was told they're looking into it. Where is our \$7,000? Why did it go to day to day operations when it was raised on the sweat of people working at the center and giving up time and not getting paid for it. What happened to our money? We can come to an agreement maybe that we could split it. But I cannot see you'll a public agency using our little bit of money that we do get and this is money that the staff raised to do activities because I understand about the money being limited I

understand about the budget cuts and things of that nature but where is our money?

Victor D. Figueroa:

Alright there's three parts. The first one is the expenses from PUI have to be spent on eligible items. I just wanted to stress that. Number two the PUI is based on a formula. So that's something that's calculated and the money that's provided is based on that formula. Number three if you're talking about \$7,000 that the prior Board had that's not under our control. They have their own private checking account and what happened to that money I'm not sure.

Cynthia Jordan-Hannah:

It wasn't underneath the prior it was turned into the Housing Authority. Ms. Baker can explain it better than I can so that you can fully understand, because at the time her and Ms. Brown-Jones was renting out the center. Also too I have another question about the rental of the center. When a person rents the center, since when do they have to get their own liability insurance. Don't we fall under some kind of umbrella?

Victor D. Figueroa:

That falls under activities that's performed under the HACC auspices so if you are having a meeting that falls under our insurance. But if there's a party or repass then that's a separate activity that's not sponsored by the Housing Authority and that's why you have to get your own insurance.

Cynthia Jordan-Hannah:

Thank you.

Victor D. Figueroa:

Do you know who that money was given to?

Malcom Isler:

Any money that is paid for the use of the community center the Housing Authority is required under the CFR to enter into a contract or MOU or MOA with the Resident Board just on the use of the Community Center. Any monies that is used to pay the community center is due to the Housing Authority is the Housing Authority's property. What we have done is we have worked with the Resident Boards to share in the proceeds that is fundraiser paid for to use our community centers, because we have to be able to maintain them. So any monies that we receive goes to the Finance Department the Accounts Receivable and is added to the General Revenue account and is used to offset items that we spend and things of that nature.

Victor D. Figueroa:

Operational items at the Community Center

Malcom Isler:

Yeah it's not like it's a separate budget and we are using it however we wish. That is not the case.

Cynthia Jordan-Hannah:

Why has it changed now because we get half and you get half? It's \$300 to rent the community center, whatever, I'm rounding off and plus they have to pay their own insurance. Why is it now that we are in agreement with you guys that you get \$150 and we get \$150? I'm stuck about that.

Malcom Isler:

The Executive Director and Edith Pagan the Director of Resident Services directed us to work with the Resident Boards and the Agency so that the Resident Board can have some type of additional funding is willing to share in the cost. That's why we came up with the MOU or MOA with each resident board on how each community center will be ran.

Gloria Wright: We've been requested by Myrmidon Pictures to allow a

filming on the site of Ablett Village and we are requesting one.... that they satisfy the City's requirement which is getting a permit but in addition we are asking for certain other information from them to ensure that Housing Authority will be protected and indemnified. There are whole other things we would like to work out with them. If there are any questions on the content of the film then of course we would have to get that from Myrmidon. This resolution asks that if we enter an MOU its subject to certain approvals and one is we would like a narrative of the particular topic subject to approval of the Board of Commissioners that will include a description and details of the subject, content, intended outcome, uses of the film, some kind of fee structure for Housing Authority for monitoring, the split of any kind of proceeds or net profit, if there is syndication, subject to negotiation with them, some assurances that the filming will not exceed the 10 days total for onsite filming to be coordinated and approved by the Housing Authority, that all filming must be conducted during the daylight hours subject to approval by the Housing Authority of the time and that Myrmidon Pictures will not solicit resident's participation in the filming, but not sure about that one.

Commissioner Person-Polk: I don't know how you can do that. Those are things that

you would have to sit with them and work out.

Gloria Wright: It is subject to negotiations.

Commissioner Person-Polk: Okay, wait a minutecouldn't we just do a resolution.

What was it that you needed?

Victor D. Figueroa: Assemblyman Barclay.....we became aware of this through

his office.

Commissioner Person-Polk:

What did you need the resolution for? Can someone come and speak to that.

Chris Cream:

CEO of Myrmidon Films. I appreciate the Board even listening and entertaining the possibility of us using Ablett Village in a couple months on our inaugural project. Our company has grown in the City of Camden and I, myself have been a long time actor, spoken word and traveled with the arts up and down the east coast. The intent of Projects the film JECTS for short, that's the millennial phrasing for housing projects like we grew up in. The intent of it is to show the dynamics of the single parent who's raising a child in areas like Ablett Village. She/He goes to work and that child is still faced with the adversities that children face in urban America. We want to address those issues to raise that narrative publicly. Like I said we're an upstart company so we don't have a budget at this point. We just have the skill and outreach to network around us to bring things to fruition. We've taken the time during the last two years to carefully write something that the people of not only Camden but Ablett Village would be proud to be a part of to just not show the plight of areas like Camden but to show the resolutions and solutions to real scenarios that really happen. I teach media production on weekends at Rowan University to children 8-18 years of age and the purpose of me individually teaching them this program is that they learn how to rewrite the narrative too often our [inaudible] are written by someone else. You referred earlier to the press being here to tell a story. Well they're not coming for that. So it's up to us as residents to rewrite our narrative and I have to and my team has to know how to write it and produce it and it takes us as a team to build it to cast it and then can we partner to rewrite the narrative of our city.

Commissioner Person-Polk:

Well one of the things that we were discussing was that we really want to be able to do this but we want to make sure that it's not negative. We don't want to be negatively portrayed. Our concern is liability and making sure that if you became successful, which we claim a lot of things here....that you would be able to, looking for something that would go back to that particular site. Not to the administration, not to us but to the site. You mention that you don't have a budget so the concern would then be how would they pay for the monitoring? Would that be pushed back as well?

Victor D. Figueroa:

We could look at it and negotiate it.

Ken Roth:

Chris Cream:

I would assume that by the time they are getting ready to go they will have a budget.

Not necessarily, films often times have to pay for themselves. We're only shooting 13 episodes over the last two years, carefully crafted to make sure we're not showing telling the bang bang shoot out, even though in reality that's not the main focus. That is not the storyline. If anything...it's the parent challenging their kids not to be influenced by the things that they see. So what we are doing with your blessing is to shoot the first two episodes as well as the trailer. We have some industry leads in terms of Netflix and different distribution houses that are interested in programming. There are certain networks that have to pick up content. There aren't stories like these being told. So we took the time to write a story that's untold because we see the market and what it's missing as well as what could be retold here. So we want to shoot the first of that as just a pitch. We could have taken our script and sold the script and be done with it as writers. We realized that we actually stumbled onto some very good subject matter and we want to stay tied to the project, which is why we have to actually shoot it to show our ability to be creative beyond just writing. So this company is more than a writing team let's bring them on board. So we can have not just one television show but multiple. I'm very appreciative of everybody that's helping.

Connie Jackson:

Commissioner Person-Polk: Okay.

Connie Jackson:

Everybody knows Jersey Joe Walcott. Chris, we've known each other and I've seen some of the work that he's done. One of the things that I know about film making is there's a lot of time that's put into it. Oftentimes we'll look at money but if you look at the hours you're looking at hundreds of thousands of dollars for doing this film. Like anything else you don't know what it's going to be. You hope and pray that it's going to be huge. So when we talk about giving back, it's not only Jersey Joe Walcott, not only his family. That's why he's here. He's definitely about giving back. I think you can be assured that when it is successful then Ablett village then becomes successful. It's on film and certainly if there are dollars generated then some of those dollars can go back into Ablett.

Chris Cream as some of you may not know is the grandson

of Jersey Joe Walcott.

Victor D. Figueroa: That's why I said net profits.

Connie Jackson: Right and this is someone who's from Camden and I think

that's one point that I really don't think you should be worried about and I'm going to be working with him and doing whatever I can to support and so it's not about money. Nobody is getting paid; everybody is giving their time and efforts to this project for free. I wanted to share a few things to encourage you and thank you and support this

young black man from Camden.

Commissioner Person-Polk: So technically we can do a resolution. I think it's a win

win. Now that we know there's not going to be negative stuff then that makes me more comfortable. That was my

concern.

Connie Jackson: They will have their insurance.

Commissioner Person-Polk: Your resolution is good so I think we can vote on it.

Victor D. Figueroa: The resolution contains the ordinance, right?

Gloria Wright: Yes.

Ken Roth: It provides for negotiation of the memorandum of

understanding subject to the approval of the Board of

Commissioners.

Commissioner Person-Polk: This resolution will allow you to move forward with that

and that should be a document that you need to do

something. Wasn't it something you needed it for?

Chris Cream: To get my permit.

Commissioner Person-Polk: Right. Commissioners are you good. Do you need to say

Village get some you know the most important things.

Commissioner Keys Frazier: We do have a lot of young folks growing up in all our sites

not just Ablett Village that have graduated from high school and went onto college pursuing their degrees. We have a lot of them. Just like we had a graduation Tuesday for the YouthBuild graduates. They contacted the news media and nobody shows up. Stuff like that is very important to us and I'm quite sure that I liked it when I first

heard about it. It's okay as long as there is not a whole lot of negativity. I know there has to be some but not a whole lot of negativity.

Chris Cream:

That is not the main focus of the script.

Connie Jackson:

Let me ask you a favor. I know we have pictures of [inaudible]. Is it possible that some of those pictures may be interjected?

Chris Cream:

Absolutely I want the authenticity.

Connie Jackson:

So the pictures that you have of a lot of those positive things that is happening. Some of those pictures if we can get some of those and that could be made into a montage than can be added into the film.

Commissioner Keys Frazier:

We have a scholarship program. Those recipients can go into that.

Chris Cream:

That is not a problem for me to bring Ablett Village those students you're talking about [inaudible] production to the site.

Commissioner Person-Polk:

I would love that because that's going to be my piece right there. Like take some of our children and train them. I would love it.

Chris Cream:

Unfortunately, I can't cast anyone in a role....but bring them on and teaching them.

Commissioner Person-Polk:

Exposure. A lot of times children learn by their environment so if they are exposed to it the opportunity.... then you never know what we'll get out of it. I like that idea.

Commissioner Keys Frazier:

A lot of children may not have the opportunity their parents may not have the opportunity to pay to go to class at Rutgers and this would be a good way. This would be a good way that's also you giving back to some of the public housing children that really like to do acting and filming. This is exciting.

Chris Cream:

there was a little incident where a bobcat was taken for a joy ride after hours. Those little mini bulldozers from the work that was taken place there. I want to thank the McGuire neighbors because of their efforts we were able to get the Bob cat back. It belonged to the vendors. Next thing Madame Chair is the 2014-2015 Annual Report is

finally out so you're getting a copy of it now.

Commissioner Person-Polk: What is this? Oh this is ours.

Victor D. Figueroa: We are working on the 2016 Annual Report but I wanted to

put this out and thank the staff again for putting this

together.

Commissioner Person-Polk: Look at that cover. That's nice! This is fabulous.

Victor D. Figueroa: I have a few more items. I want to report that on October

12th, I believe it was, I met at the Jim Florio Center with the County they put together a Puerto Rico Relief roundtable team and that was at the request of Senator Nilsa Cruz-Perez, Freeholder Carmen Rodriguez and Council President Frank Moran. So there was the social services aspect, Camden County Board of Social Services was there, a whole slew of different organizations including us and we're trying to help just in case there is an influx of folks coming from Puerto Rico to Camden that we have enough services ready in case they do come and they have started.

Commissioner Person-Polk:

Where else can they, they have nowhere to go?

Commissioner Correa:

Yeah I had a question.... we had one case Friday and I don't know if they had social service so let me ask Housing be informed about that too. They said they going to have 4 months and after 4 months they have to bring all the documentation they need.

Victor D. Figueroa:

At that meeting I indicated that our waiting lists are open at the senior properties. The family sites are closed. I did reach out to HUD to see if there is some sort of waiver and they are working on that through the Section 8 program. Theresa Arce who is the Public Housing Director for the State of New Jersey sent out a recent notice that they're still working on it and I'll be sharing that with staff. There are some waivers that will be granted.

Commissioner Person-Polk:

There should be some way that the vouchers that they already had existing that those vouchers could be used. Yeah port over here. It's allowed by the law and so they should be able to do that as well.

Commissioner Correa:

I don't think so – they haven't been working with that

Commissioner Person-Polk:

They have to. Because what happens is if you get a Section 8 voucher and you have it for a year you can relocate to any state anywhere and what I'm saying is whether they work with it or not they have records of all the Section 8 people that was on that island.

Victor D. Figueroa:

They're also working on waiving that one year requirement.

Commissioner Person-Polk:

Because that is resources that will not be utilized in their area so they should be able to use it. Right. That way we could provide you know quicker assistance.

Commissioner Correa:

Most of the people they bring over is a medical issue.... very bad medical issues. The case that we had Friday was

someone who was very sick. At Voorhees Hospital, the person was discharged on yesterday and put in a taxi and sent to welfare. It was almost 3:30 in the afternoon when this happened.

Commissioner Person-Polk:

You should be speaking to individuals in the County government and Municipal government and the hospitals. There should be some level of sensitivity.

Commissioner Correa:

But they don't have it because the welfare office they don't want to help because they don't have documentation and when I went downstairs and the person went to the welfare office.

Commissioner Person-Polk:

They need to have a little more meetings to refine the process because I doubt that will be the only one resident.

Victor D. Figueroa:

The round table team will be meeting again and as Madame Chair was alluding to the Connect Home visit went very well. We met across the street and HUD was very pleased. Dina Leaman who's the coordinator for HUD headquarters was pleased and met with staff including Edith and Daniela. They're working some things out, since we met our goals ahead of time they want us to increase our goals and I'm not sure Edith if we finalized that issue because they wanted to increase it by 20% I said no since we have to be practical. So was it 70% now.

Commissioner Person-Polk:

You know what I liked about that particular meeting, this is with staff and everybody have to remember whatever you say even if you are mad at your boss or you don't like something that went on at the Authority. Hold your tongue because a lot of times we are our own worst enemy. That meeting showed whether people liked it or not that you're doing a good job. We're not getting the recognition of the work that is being performed, right. I had to straighten a couple people out because one person made a statement "100 people at Roosevelt Manor and they're not cleaning up" and I stopped them because number one I'm sitting on the Board and took it as an offense. Don't join in! Because if you don't say something is just like agreeing with them and to make that statement in front of people that don't necessarily know about and already have a view of poverty as people being lazy. Already has that view and they going to tear up the property. They're not tearing up Roosevelt Manor. It's beautiful. People fail to realize that when you run your mouth and say something negative, you don't know where it's going to go. It ruins people's reputation.

Everybody is out working..... all the Commissioners on the Board are doing the best that they can. So whenever you go somewhere it might be something you don't like but it's not 100% that you should like everything because who are you? Sometimes decisions are made because there are a lot of factors that have to be put in there to make that decision that you may not be aware of. Because what happens when people start eroding the institution that's doing good work. People say well they not talking about me, but if you work here they are talking about you. With all these cuts that's coming down the road. I worked at the Board I watched people just destroy people through their mouth. Nobody knows if someone is tainting you bad with their mouth. Then programs and everything suffers. So if you don't have nothing good to say about the Authority don't say nothing. If you in the room and they talking about anyone on the staff or somebody you don't like shut your mouth! Our problem is we don't push each other up. We got to work together, these are rough times and might get worse. So what happens when they start chipping away whose ever name is out there "that person is no good" they be chipping at that person but that don't mean that they'll get you next. Because that's how it works they erode institutions. When you see them walk in and they say we're getting rid of x number of dollars at HUD.....Poor people are not stealing that money- we provided a service. And then the guy that made the statement doesn't even realize what the services are. I'm proud to say that I'm on this Board and that I work for you guys. Just in my heart. It happened quite a few times. If you get an opportunity to say something good about us or say something good about your staff or your job or some of the programs because you know what nobody tooting your horn. Nobody! That YouthBuild program over there it's saving lives. If it's one that is wonderful. Nobody knows the work that it takes and everybody that works for us is dedicated to their job. I'm just glad that we have an appreciation thing. So people know we appreciate you. Nobody here is working unnoticed. If we don't say your name doesn't mean we Commissioners all here don't approve of your work. Ok that's enough.

Victor D. Figueroa:

There's two more things. The independent audit was completed and the Board will receive a report in November. It was pretty much clean audit.

Daniel Aronson:

To reiterate what the director said we received our unqualified audit opinion for the year 2016 and the auditor

will show up in November 8th to answer any questions you

may have.

sound negative.
