Message From the Executive Director Dr. Maria Marquez

"Responding To Change"

Dear Friends and Colleagues:

One of the most difficult parts of leadership is fostering and managing change. In promoting change, we have transformed the face of public housing in the City of Camden. We have come to realize that change affects everyone. It is important that all stakeholders be involved in understanding and effecting the change process. History is full of examples of organizations that have failed to change, and, therefore, are now defunct.

As the housing industry continues to evolve, our PHA continues to evolve as well. The ongoing proposed and mandated changes alter the local goals of a PHA which provides services to the residents, including but not limited to decent, safe and affordable housing. In the last five years, the housing authority has grown and has diversified its portfolio by assessing its population needs and securing available dollars at the federal and state levels. We have privatized four of the ten developments, three of which have received HOPE VI grants and one secured a Housing Replacement Factor grant.

Due to the increase of the number of frail elderly residents, HACC now operates and manages three housing towers, two of which have been elderly designated. This designation will provide additional services through a State Funded Assisted Living Program (ALP). The ALP provides its clientele with services, such as homemaker/share service, counseling, case management services, medication monitoring and administration, recreational services, medical and nursing assessments as well as transportation for visits to and from doctors' offices. This program is available 24 hours a day and seven days a week.

In understanding the importance of health services for our residents, HACC partnered with the CAMCare Health Corporation to provide medical services at our latest awarded HOPE VI site, Roosevelt Manor. The newly developed site now includes a multipurpose community center for all social, recreational and medical activities. CAMCare Health Corporation operates throughout Camden, New Jersey. CAMCare will be providing our residents and its immediate community comprehensive primary care and dental services. The community is also looking forward to a state-of-the-art day care program to provide services to 32 toddlers from public housing. The surrounding community residents between the ages of two and a half and five years old will also be able to participate.

In meeting the needs of our high-risk youth, HACC is very proud of our YouthBuild program. This is a youth and community development program that simultaneously addresses core issues facing low-income communities. It focuses on housing, education, employment, crime prevention, and leadership development. Youth and young adults ages 16 to 24 work toward their General Equivalency Degree (GED) or high school diploma, while learning job skills by building affordable housing for homeless and low-income individuals. Strong emphasis is placed on leadership development and community service.

As you can see, over the last 8 years, HACC has come a long way and has shifted from just low income public housing, to administering a Section 8 program, Homeownership, Turnkey Project, Project-Based Voucher Program, public housing units that are part of mixed-finance developments and Asset Management.

The support of the entire Board of Commissioners has assisted the agency in the celebration of these major milestones. Their unwavering support is greatly appreciated. The support and dedication from the staff and residents alike has continued to help us grow stronger and for this I am thankful and very grateful.

2008 - PROPERTY MANAGEMENT <u>"Staying Connected"</u>

The Housing Authority of the City of Camden continues the transition to asset management which began on September 19, 2005 and is to be completed in 2011 per HUD guidelines. HUD published a final rule on the Operating Fund [24 CFR 990.165(i)], which included a "stop loss" provision that enabled a Housing Agency that would experience a loss in funding to demonstrate it has converted to asset management and minimize those losses. PHAs that prove successful conversion will be able to reduce their losses at 5% as opposed to 24% estimated to be at \$578,000 for HACC. The HACC persists in its drive to improve the services it provides its residents and is happy to announce that after a rigorous HUD audit, earlier in the year, in August 2008 it received a letter from HUD that stated, "... in accordance with PIH Notice 2006–35, the HACC has demonstrated a successful conversion to asset management..."

SUPPORTIVE SERVICES

The Resident Services Department provides supportive services to the residents of the HACC. The staff is always on call for crisis situations and to answer resident emergency situations. Typical clients who are receiving service today include individuals who are near homeless, unemployed, under-employed, public housing or Section 8 residents, victims of domestic abuse, substance abuse, mental health, individuals and families at risk, and families in crisis.

Programs provided to residents during 2008:

- (1) Social Services: 24-hour crisis intervention for residents of public housing.
- (2) Adult Basic Skills Grant: Adult education in ESL, GED, literacy and ABE.
- (3) YouthBuild Grant: Construction trades and academic training program for at-risk youth aged 16 to 23.
- (4) Community Centers Safe Haven Project: Provides six after-school programs and six summer camps at all HACC family sites.

- (5) Senior Services Program: Provides daily assistance to HACC's elderly population.
- (6) Neighborhood Network: Computer training program.
- (7) Homeownership Program: Assists residents of public housing and Section 8 to use their vouchers to purchase homes.
 Program currently has 23 residents of public housing in the process of purchasing homes.

Affairs and Events:

- Senior Prom: Successful event held on May 9, 2008 at the Crowne Plaza hotel where the elderly population of HACC relived their senior prom. King and Queen of the Prom were also crowned.
- (2) Senior Field Trips: Monthly trips are provided to the elderly population for neighborly hospitality and friendly socializing. Four to six larger trips were held for those who enjoy museums and sightseeing.
- (3) YouthBuild Graduation: On May 16, 2008, 38 students graduated from the construction trades program.
- (4) Job Fairs: Six successful job fairs were held in 2008; three in the spring and three in the fall at Ablett, Chelton, McGuire, and the Centerville library for the residents of the Roosevelt Manor HOPE VI program.
- (5) Summer Programs: Six successful summer youth camps were held from June 23 to Aug. 29, 2008 at each of the HACC family site community centers.

The staff members at the Resident Initiatives Department and HOPE VI Social Services look forward to providing another great year of programs, events and cultural affairs at HACC.

MODERNIZATION HIGHLIGHTS

"COMMUNITY INVESTMENTS AND GREEN INITIATIVES"

GOING GREEN

The Modernization Department instituted green initiatives throughout public housing sites to provide cost savings to the Authority and residents in the form of electrical and energy savings.

The Housing Authority of the City of Camden (HACC) and Water & Energy Savings Corporation announced their partnership in a major resource conservation program at HACC's public housing developments. The program reduces water consumption by more than 50 percent and energy consumption by more than 11 percent. It also provides significant improvements to the homes of HACC residents.

Through the program, low-flow toilets, low-flow shower heads, low-watt compact fluorescent fixtures, weatherization – doors and windows, and upgrades to exterior lights were completed. The utility savings program is one of many major initiatives launched to improve living conditions for HACC families.

HOPE VI COMMUNITY SUPPORTIVE SERVICES

Community Supportive Services (CSS) Program

The HACC HOPE VI Program has and will continue to offer Case Management Services for a total of 288 families. HOPE VI partnered with 18 Community Service Providers to assist families to get on the path to self-sufficiency.

Boys and Girls Club: 40 children ages 6-12 attended the Summer Boys and Girls Club Summer Camp, paid for by the HOPE VI Program.



HACC Youth Programs: Provided Safe Haven Programs such as a HOPE VI Internship Program for youth ages 14 to 18, Partnership with Resident Initiatives for the HACC Summer Youth Program for ages 6 to 12 that served as an avenue for our youth to participate in educational and recreational activities throughout the school year and summer school break.

• *Internship Program Award Ceremony*: All youth who participated in the HOPE VI Internship Program were honored upon completion of the program.

<u>Certified Nurse Assistant Training:</u> 12 adult residents enrolled and completed the LTC CNA Training, and were then assisted with job search.

Relocation Mobility Counseling: Provided by the Case Management staff for all residents who desired to return to the newly developed Roosevelt Manor HOPE VI site.

Assisted Living Program

HACC's Assisted Living Program, which is currently operating within Kennedy and Westfield Towers, was established to allow clients to age in place, by helping them coordinate healthcare and daily activities by using around-the-clock staff. A full-time registered nurse on call 24 hours a day, seven days a week monitors the clients by doing wellness checks and communicating any changes with their physicians. The participants in the ALP also receive medication administration assistance by nurses on a daily basis.

MEAL PREPARATION

PERSONAL CARE ASSISTA BATHING & GROOMIN

• In 2008, the ALP provided primary care providers for clients in the privacy of their apartments for those clients who preferred not to go out. This eliminated long waiting times in physicians' offices and afforded clients the continuum of medical care for chronic conditions.

• Compliance with clients' medical needs. Lab work, X-rays and EKGs were done in the privacy of the individual's apartment.

• The monthly wellness checks to monitor the clients' health status also helps to decrease the need for hospitalization because a registered professional nurse can communicate any changes to a physician, and medications can be added or changed through this channel of communication.

2008 Accomplishments

► The Housing Authority of the City of Camden provided employment opportunities to 50 young adults through its Summer Intern Program. In addition to preparing them for future employment, the program also allowed the participants to serve as role models within their communities.

► HACC hosted its eighth Zeaida Hutchinson Memorial HOPE VI Scholarship Fundraiser. Four recipients were awarded \$2,500 scholarships; three attending Camden County College and one attending Rutgers University. During the Humanitarian Awards ceremony, Sara T. Davis, president of the Camden Board of Education; Kathryn Kirkland-Blackshear, a civic leader in the city; and Kevin Vallen, a Section 8 Landlord of the Year, were honored.

► Addressing criminal activities within the public housing complexes, HACC joined forces with the City of Camden through the execution of a memorandum of understanding. The Camden City Council approved the ordinance that went into effect July 14, 2008.

► On May 16, 2008, a group of 38 Camden students graduated from the Construction Trades Program. The students had successfully completed carpentry, masonry and building maintenance courses.

► HACC opened its public housing waiting list to Camden City residents twice during June 2008. It was the first time HACC opened its waiting list for all of its properties at once.

► On August 19, 2008, HACC received a congratulatory letter advising the agency that it has demonstrated a successful conversion to asset management and thereby saving the agency from a permanent subsidy loss of \$578,000 per year.

► Six Successful Summer Youth Camps were held from June 23 to August 29, 2008 at each of the HACC Family Site Community Centers.

► Residents enrolled in the American Community Partnerships (ACP) Construction Trades Program, with two sessions held. Additional trainings such as Office Skills, Sexual Harassment in the Workplace and Basic Computers were obtained.

► A total of 12 residents enrolled and completed a CNA certified training course. All were assisted in obtaining jobs.

► The HOPE VI program hosted a job fair and partnered with Atlantic City's Borgata Hotel & Casino to employ city residents. Transportation was provided for interviews of final candidates.

► HOPE VI provided working parents the opportunity to send 40 youth to the Boys and Girls Club's Summer Program.

- ► Six successful job fairs were held.

LOOKING AHEAD

Partnership to Prevent Crime

In keeping with the theme of "Celebrating Safer Communities," the Housing Authority of the City of Camden partnered with the Camden Police Department to continue to deter and prevent criminal activity within our public housing developments. A kick off-event was held at Ablett Village on Friday, Aug. 1, 2008, to mark the signing of a memorandum of understanding.

HACC Executive Director Dr. Maria Marquez, Chairwoman Deborah Person-Polk, Vice Chairwoman Marilyn Torres, and Housing Manager Malcom Isler were joined by Camden Mayor Gwendolyn Faison and key city and community leaders.



Understanding of the MOU

The Memorandum of Understanding authorizes the City and the Camden Police Department to enforce statutes on behalf of the housing authority by issuing summonses, warnings or arresting residents and non-residents of the public housing developments, employees of the housing authority, or invited guests of the authority if those persons violate state, federal and local laws, including defiant trespass and loitering



for aforementioned illegal purposes, consistent with state law and City ordinances and as further proscribed within the meanings of <u>N.J.S.A.</u> 2C:18-3b, <u>N.J.S.A</u> 2C:33-2.1 and <u>N.J.S.A</u>. 2C:34-1.1, upon the premises of the public housing developments of the authority.

All HACC public housing developments will erect "No Trespassing" and "No Loitering" signs to deter all potential offenders. Additionally, site management will strictly enforce the dwelling lease and the "One Strike Policy." It is the continued mission of the Housing Authority of the City of Camden to provide <u>safe</u> housing for all residents, and the signing of the MOU with the City of Camden clearly acknowledges this undertaking.

Looking Ahead

The HACC looks forward to a great 2009. The HACC anticipates to be awarded various grants applied for this year and complete continued site improvements at our most of our public housing developments.

Homeownership

The Section 8 and Resident Initiatives departments continue to hold homeownership classes geared at preparing public housing residents and Section 8 clients to become homeowners. With the HOPE VI redevelopment of the Roosevelt Manor housing development, homes will be built for the purpose of homeownership. The HACC anticipates that participants from the classes will be future homeowners in Roosevelt Manor.

Assisted Living Program

We anticipate an increase in enrollment in the Assisted Living Program. The benefits of this program are being spread through word of mouth from participating clients. Staff of ALP is taking tremendous pride in assisting the residents of Kennedy and Westfield Towers to age in place.

HACC Web Site Development

In an effort to be more transparent, the HACC has begun working on a new Web site. The Communications Committee is working along with South Jersey Technology Partnerships to develop the site. It is the HACC's hope that our new site will allow residents and the general public to explore the directory of programs, services and additional resources offered within the HACC. The site will also include postings of the board of commissioners' agendas and minutes, event schedules and jobs.
