# **NEW BUSINESS:**

Victor D. Figueroa:

Welcomed Commissioner Luis Quiñones.

Welcomed new staff member, John Kostyal, Human Resource Manager.

Informed commissioners of moving forward with obtaining the Assisted Living Program license. We are a little behind in that, but I want to thank Malcom Isler and his staff for seeking out the licensure so we are pretty much in communication now with the Department of Health in Trenton. Basically we are awaiting for the license number. There was a certificate of need that needed to be applied for and different processes, so once we get the license number then we can apply for the Medicaid number and then after that we have to go through each individual HMO which pays for the participants portion of being in the program, so we will have to individually go after each HMO to be able to start getting reimbursed for the services that we will be providing. Hopefully this program will start on June 1<sup>st</sup>.

Commissioner Keys Frazier:

How many participants are in the program right now?

Victor D. Figueroa:

Not as many as we had before, I believe it's down to 23.

Commissioner Keys Frazier:

People are telling me that people have gotten out of the program because the current agency is not doing a lot of things that they should be doing for them. Because once we take over we need to strongly, strongly ask the residents to get back into the program. We have to push our program.

Victor D. Figueroa:

Commissioner, word has gotten out that we are taking over and former participants are saying they can't wait because they want to join the program again, so we are working on that.

I'm not sure if we announced this because we missed the March meeting due to the snow, but we received a regret letter from HUD related the Choice Neighborhood Planning Grant for Ablett Village. So, we asked for a debriefing and got the debriefing this past week. I just wanted to announce that when we first got the grant, we got 54 out of 102 possible points, but then we were in the debriefing we asked the question how many awards were made, what were the lowest and highest scores, so basically there were 6 awardees and the highest score awarded was a

84 with the lowest score being awarded was 59, so we were 5 points away. As many of you know the history, if we would have gotten more local support I think we would have gotten it. So, basically the NOFA has come out, CNP Grant, we are looking at it and will be applying again. I have already spoken to folks at City Hall and they are in full support of us applying, so we will be applying again. The deadline is in June.

We are still awaiting for the Jobs Plus Grant to be announced for Ablett Village. I think we submitted in September, so we are still awaiting and still in the running.

Congratulations to Traci Willis, our SEMAP score came in at 93%, makes us High Performer. Thank you very much to you and your staff.

REAC inspections, we have gone through 4 so far, we've got 90's in 3 of them and 84 in one of them. The 84 was the lowest out of all, but was an improvement from last year of 77, so we get a waiver of two years not having to do a REAC inspection. I want to congratulate Malcom and his staff.

Lynn Patton, Region Administrator for HUD for the NJ and NY office, recently paid a visit to Camden meeting with the Mayor and other invited staff. They were pleased to see the progress taking place in Camden, taking back some talking points. I sent a follow up from the meeting via email, as well.
