Executive Director's Report for September 2018:

Our Director of Finance just retired and we temporarily hired BDO Financial as a Fee Accountant. the Fee Accountant that we had on contract was not able to give us the time that we needed to help us in moving the department forward and to start preparing for the 2019 budget and everything that the Finance Department does at this time of year.

Errol Shorter is no longer with the Housing Authority. He was overseeing the YouthBuild Department but he is no longer working for us. Mr. Shorter helped HACC with Grant writing. We are still waiting for the YouthBuild Grant and we hope to hear from the Department of Labor if the grant has been awarded to HACC.

Commissioner Person-Polk:

Who is currently taking over that responsibility?

Victor D. Figueroa:

In the interim, Deputy Executive Director, Kathryn Blackshear. There are also other personnel at YouthBuild who are helping with these responsibilities.

HACC was surveyed by the State of NJ. HACC has been approved with an operational license and we are officially an Assisted Living Program (ALP). We have hired staff and appointed an Administrator, a Director of Nursing and complementary staff.

Commissioner Keys Frazier:

With the new people taking over as of today what about the workers that have been working...who are the full time people?

Victor D. Figueroa:

The only personnel that are full time are the Administrator and the Director of Nursing The Administrator is a new person, the previous person found a new job; the Director of Nursing was a former employee. The current staff under DPSP has been reassigned to work for Watson Street ALP on a 90-day probationary period to be determined if we are going to make them full time.

Commissioner Keys Frazier:

The workers for the Home Health Aide, some of whom have been with ALP for a long time and whenever a fulltime position becomes available, would these persons be offered the positions first?

Victor D. Figueroa:

They would be considered for the position.

Commissioner Keys Frazier:

Asked what is the meaning of "if it becomes available"?

Victor D. Figueroa:

Explained all the positions in regard to the ALP are part time positions, except for the Administrator and the Director of Nursing; the personnel are all working as part time per diem personnel through DPSP.

Commissioner Person-Polk:

I would like to be introduced to the Director of Nursing and Administrator.

Commissioner Keys Frazier:

What is the name of the Director of Nursing?

Victor D. Figueroa:

Michael Duggard is the Administrator and Maggie Zimmerman is the Director Nursing. Ms. Zimmerman was the Director of Nursing before... she left and came back.

Commissioner Person-Polk:

We would like to meet the employee from BDO and the nursing staff; it would had been nice if they attended the Board meeting.

Victor D. Figueroa:

We are also working with NW Financial.

Commissioner Person-Polk:

We would like to meet with the people from NW Financial. We would like to stay involved with all the recommendations and activities regarding financial decisions. We had prior problems with the ALP so we will have to watch the proceeding for a little while, to ensure the individuals are doing what they're supposed to be doing for our residents.

Suggested a Special Meeting in the Executive Conference Room to meet with the ALP personnel, BDO and NW Financial and bring all portfolios. Victor D. Figueroa:

We will coordinate with the Commissioners to have the

Special meeting.

The independent audit which was required to be submitted was sent to HUD by the deadline which HUD has received.

Commissioner Person-Polk:

We need a copy of the audit.

Victor D. Figueroa:

Explained not yet, as we just received them but would give a copy to them later. Richard Larson will be presenting the audit at the next meeting.

Commissioner Person-Polk:

Please ensure that we have the audit soon, so we can review them before next meeting.

Victor D. Figueroa:

We will distribute them by the end of this week.

MTW the 'Moving to Work' designation is out now. HUD has put out a notice and it's our intention to apply for that. I want the commissioners to keep that in mind; it just came out and I'm not sure when is the deadline but we will be applying for the "Moving to Work" designation.

Commissioner Keys Frazier:

Can we know when the deadline is so that we won't miss the deadline, we need to know the date...

Commissioner Person-Polk:

Please provide what "Moving to Work" means for the commissioners...and what the designation means and what impact it would have on the Authority, in particularly with the residents. As soon as we apply for the "Moving to Work" we need to have all the information and materials in order to do our job and be frugal with our dollars. We have to make sure we understand the impact it will have on the Authority and with RAD. There may be a lot of moving pieces that needs to be addressed.

Victor D. Figueroa:

Explained that 'Moving to Work' provides the Authority greater flexibility of how it spends its money, right now the way it works is that Public housing is earmarked for Public Housing, Section 8, is earmarked for Section 8, it allows a greater flexibility from how to spend the money and the regulations.

Commissioner Keys Frazier: Everlynia Hudson, 2019 Westminster Ave, had complained

that there was a foul odor coming from under her house...

Malcolm Isler: It's the sewer system.... the City's Director of Public

Works have been notified for a second time with regard to that issue and he said he was going to address it with NJ

American Water.

Commissioner Keys Frazier: How long ago was that...?

Malcolm Isler: We did it the first time, we complained about it in July, we

noticed the City about it, this came up again at the last board meeting in September and we again sent another email...it's a City issue that they have to address with NJ

American Water...

Commissioner Keys Frazier: Is the resident supposed to live with the smell, which

maybe a health hazard.... it is unfair to the resident and if she has children.....to have to wait on the City and water

company, etc...

Victor D. Figueroa: I will personally bring up the issue with the Mayor's office.

Commissioner Keys Frazier: The resident is still in this unit, can we transfer her to

another unit?

Malcolm Isler: Explained that it's not just her unit... it's the entire street.

The smell comes and goes, it's near the bottom of Westminster as you get closer to Randolph Street with the sewer system in that area. The residents were informed that Michaels is aware of the issue and that problem will be included under the improvements under the RAD project. The Board took a position that they were going try to help us by addressing the issue with the City officials to try to get it addressed.

Commissioner Keys Frazier: This is a bothersome issue, its health concerning. We don't

want to be sued, as well as the City.

Commissioner Person-Polk: It's not HACC's responsibility...the problem lies with the

City of Camden.

Commissioner Keys Frazier: This is a health problem and we cannot wait for the City to

address this issue, the issues needs to be expedited

immediately.

Victor D. Figueroa: Asked his staff to remind him to address the issue with the

Mayor's office tomorrow.

Commissioner Keys Frazier: What is the status of the Caterpillar issue?

Malcolm Isler: HACC received three (3) quotes for services; a requisition

was put in to Miller's Tree Service to remove the two

smaller trees.

Commissioner Keys Frazier: Why do you have to remove the trees, can't you get an

exterminator??

Malcolm Isler: Explained that he was instructed to remove the trees.

Victor D. Figueroa: The tree produces these caterpillars every year, so it's an

annual problem beginning in September, so it's wise to

remove the trees.

Commissioner Person-Polk: Are there any other comments from the Commissioners

regarding the Executive Director's Report?

Commissioner Cunningham: The trees definitely have to be removed because the

Caterpillars will come back every year so it's cheaper to

remove the trees than it is to maintain them.

smells very bad and leaves a residue and cause

discoloration to the bathtub. I got a rash from the water and cannot use the water unless I boil it to brush teeth. What can we do as residents to move forward to get the

ball rolling??

Commissioner Person-Polk: These are two separate issues: (1) is American

Water/Sewer and (2) Discoloration and foul smelling water.

Victor D. Figueroa: Two issues and I will be bringing the issues to the Mayor's

attention; the City is trying to address this issue with

American Water.

Commissioner Person-Polk: Suggested that the water should be tested and the residents

should be notified.

Laverne Williams:

1655 Park Boulevard - How successful is the YouthBuild Program? After training from the YouthBuild Program, where are they working? Do you have affirmative action within the Housing Authority... To ensure the kids get jobs within the City of Camden. What is OSHA training, are people getting jobs from this OSHA training program, how much do they get paid?

Victor D. Figueroa:

If Jobs are available they can apply, if there are no jobs they are referred to the Workforce Development Board or the Camden County One Stop Center. It is a federal law that they get hired after training.

Yocontalie Jackson:

Choice Neighborhood Coordinator - Yes there was a ten (10) hour OSHA training; Sixteen (16) people went through the training, some of the individuals were from the YouthBuild Program and others were from Branch Village and other places within the Housing Authority. purpose of the training was to prepare them to work on the Branch Village project, where they will be building the Townhomes. We couldn't have anyone working on that site that did not complete the ten (10) hour OSHA training. There are three (3) individuals from Branch that are currently working on the Branch site doing demolition. The demolition is in the first stage, after that they will be going to other stages of construction which has not happened vet. There is still a lot of work to be done. We anticipate having twenty (20) individuals working on the site. Another thing that we are doing is when we get information from the One Stop Center, we ensure that the case management/case worker get the information so that they can share the information with the residents of the Housing Authority so they can apply for the jobs. We also have individuals who work for the Action Pack, which is a packing facility. We had eight (8) individuals who worked there as temporary employees for ninety (90) days and then they would get hired permanently. We are actively working to get individuals hired.

Laverne Williams:

Is concerned about Section 3 - they are supposed to hire Camden residents... the concerns are under Section 3... are residents being hired?

How many one-bedroom houses are being built in the second mid-rise?

Charles Valentine:

Prior to the meeting Ms. Williams asked me that question, specifically about the one-bedrooms in the next phase

because they're Townhouses at Branch Village, so she can move back. I told her I would get her the information.

Ella Baker: Ella Baker, President, McGuire Gardens – re: petition for

Donna Ellis, not to return to McGuire - Why is she coming back to McGuire Gardens? We are trying to move forward.
