NEW BUSINESS

Victor D. Figueroa announced that the groundbreaking last week was for Phase 4 for Branch Village for the Choice Implementation Grant as well as a joint RAD site. They received the Proclamation Resolution from the joint legislator, which is Senator Nilsa Cruz-Perez, Assemblyman Bill Moen, and Assemblyman Bill Spearman.

Mr. Figueroa read the last WHEREAS, presented on February 12 where it states, "It is altogether proper and fitting for this legislature to recognize the groundbreaking ceremony for Clement T. Branch Village, Phase 4, and affirm its future essential role to the citizens of Camden. Now therefore be resolved by the Senate and the General Assembly of the State of New Jersey that this legislative hereby notes the groundbreaking ceremony for Clement T. Branch Village, Phase 4, pays tributes to all those whose efforts have contributed to this praiseworthy endeavor and extend sincere best wishes for its success and vigor in the years ahead."

The Proclamation was presented to Victor D. Figueroa, Chairwoman Polk, and Commissioner Soria-Perez who was there and was accepted gladly. It was a standing room only event, very well represented by all folks of the city, county, and the state. New Jersey HMFA was there as they provided a substantial amount of money, tax credit awards for the project. The Mayor was happy and satisfied. Lynne Patton attended, who is the Region II Administrator. Mr. Figueroa thanked the staff for their efforts in making that a worthwhile project and a success. Stated it was almost finished.

Commissioner Person-Polk stated they usually hear complaints, which they don't mind because that's why we're here. But, for this phase and this project, it took a village for it to happen. Residents, politicos, funders, and everyone were there. Stated that some areas of Branch Village weren't the nicest. Residents can now be proud. They have units, it's not substandard housing, and beautiful, nice streets. It's a welcome improvement into that neighborhood.

She stated that some people believe that if you don't make a lot of money that you should get less. She's not one of them. She volunteers because even though you don't have all the money, you don't have to live in substandard housing. She was happy to see this other phase, as all the other phases, and it's changed that Centerville neighborhood. Suggested people go see it. Stated it couldn't be done without the commissioners. Stated it's a village and everyone worked hard, and

she was glad to be part of something so positive. Stated that Camden is one of the poorest cities in the country, one of them. To get these awards and improve these neighborhoods is spectacular because it's very competitive. She commended the staff, has their back because she knows what they have to do to get the money, get the projects up and going. She stated we should applaud the staff for their work. Stated we can always find something wrong, but when it's something good, you can hear a pin drop. Stated things have to change by seeing what good is being done especially at the Housing Authority. Stated she's thankful because she can't remember getting awards for other phases. Stated people are acknowledging that money is spent where it's supposed to be. Stated it wasn't years ago, it's been changed. Stated you can touch, see, and feel the money. Stated she's thankful to the staff and gave them a round of applause.

Commissioner Cunningham stated when people visit her, get off Walt Whitman Bridge and come down Master Street, they don't believe that's public housing; she's impressed with Branch. She rides down 9th Street and up 10th to see what's going on. Stated it's amazing and she's proud to say she lives in Camden. Stated they have the best public housing going. It's better than most of the private homes.

Commissioner Person-Polk stated because of the way public housing was structured, everything was encased like a super block. All crime was all in that block, and people felt they weren't a part of the community. Stated now the streets go through homeowner streets, and it's easy access for the police, fire department, and everyone.

Commissioner Miller stated he had questions on the Executive Director Report.

Commissioner Person-Polk stated it was already approved and on to New Business. Stated we'll just go in order and then deal with that.

RESOLUTIONS 20-04

Resolution 20-04 – Wanda Riley, Asset Manager, Resolution 20-04 is the resolution requesting the approval of the amendment of the Public Housing Admissions and Continued Occupancy Policy to reflect and establish the new utility allowances for FY2019 for certain asset management properties and the Executive Director's or his designee's authorization to execute documents and to do all things necessary to effectuate the transaction.

Commissioner Person-Polk asked if there were any questions from the public.

- (a) Laverne Williams, 1655 Park Boulevard, Camden, NJ, wanted to know how they arrived at the new utility amount? Mr. Miller stated it costs \$3,000, Operation budget, and that rents would decrease when children leave. She said that's not always true, and it depends on how much your rent is. It depends on your bedroom size.
- (b) Commissioner Miller asked to state on the record how much did this study cost? The study cost for all 13 properties analyzed, it was \$3,000. Please repeat what budget the funds came from.

Wanda Riley explained that the funds came from the Operations budget. The company was-McGrann Associates, yes. How were they chosen and when? I don't know when they were chosen or how they were chosen. They did announce this last year, so I used them again this year. Jasmine Kee, Purchasing Specialist for HACC stated that as Wanda Riley stated, McGrann Associates were used last year. For this year, it cost \$3,000 for a total of 13 properties, divided by

that each call center subject to that amount. By the State of NJ Rules & Regs, this one quote was sufficient. Commissioner Miller asked if based on their experience, that's why we used them? Ms. Kee confirmed.

 Ms. Melody Williams stated it's due February 29, 2020; she's working on the certification, which will be submitted prior to the 29th.

- Crestbury residents are having problems. Does HACC have anyone from Public Housing in Crestbury or under the Section 8 programs? And if so, how many?
- Rent went up with cost of living raise (COLA) for seniors and got a small discount on utility costs. Something is wrong. Her utilities are very, very high. HUD gave a utility discount. She's paying more utility than her rent. Something is wrong with HUD, not enough for utilities.

Commissioner Miller stated that in the Executive Director's Report, page 6 and 7, under Accomplishments and Ongoing Tasks, there's ten bullet items. Items 2 through 10 are all openended items that he'd like to get from John timeframes on as to when these tasks are expected to be completed. Some are under review, some are submitted for approval, some are still ongoing data collection. The Board needs to know what kind of timeframes we should be looking at for all of these different tasks to be accomplished.

Also in that report is current Job Announcements; and there are eight items, of which the first four he is asking why is it taking so long? There are some explanations, but some of these positions go back five, six, seven months; and some are fairly substantial positions. He asked what's holding up these? He'd like an update on that. On number six of that list, he'd like to know what the responsibility of that position is going to be and to have that information at the next meeting.

PUBLIC PARTICIPATION

Antoinette Daliaduby, who works for the Michaels organization, stated that she was happy to hear that you guys received the proclamation and she's looking forward to finishing that project with all of you. She stated that she's here to say positive things, not negative. She's worked in the housing industry for the last 18 years and has had the pleasure of working with 39 different agencies, state and local. Stated that this is one of the better establishments to work with, an open relationship by email or phone, even provided translated documents in Spanish for her. Thank you.

Ms. Daliaduby mentioned that on February 26, 2020 there was going to be a job fair at McGuire exclusively for the residents of McGuire Gardens and to please encourage local residents to come out and apply for a job. There are some that are for painting, some for laborers, and some for the moving company that moves people in and out. An earlier job fair in August was for the McGuire residents and the rest of Camden was successful. Michaels want to give back to the locals, to boost the economy. Ms. Daliaduby also said she was also looking for two administrative assistants looking for work in Camden.

Commissioner Miller asked her, on behalf of her organization, to look at the trash cans that were overflowing and have somebody address the issue. Commissioner Miller said it should have been done before the Commissioners arrived for the Board Meeting.

Ms. Daliaduby informed Commissioner Miller that an email had already been sent regarding the trash.

- Commissioner Person-Polk stated that the condition of the blinds disturbs her, and joked about "What gets monitored gets done."
- Victor Figueroa informed Commissioner Person-Polk that the room is going to be painted.
- Ms. <u>Daliaduby</u> said that two new maintenance positions were posted for the project; and we're looking for a bilingual maintenance person.
- Commissioner Miller stated that a meeting was being held tomorrow for the residents of Mickle Tower to discuss the <u>RAD</u> at 3:30.
