EXECUTIVE DIRECTOR'S OPENING STATEMENT

Executive Director, Victor Figueroa, spoke about three residents that passed away due to COVID-19 at McGuire Gardens. He asked Commissioner Deborah Person-Polk to read a Proclamation for Mrs. Cynthia Jordan-Hannah, Vice President, McGuire Gardens Resident Association, that we unfortunately lost due to complications from COVID-19.

Resident Initiatives staff delivered food to the residents at the three towers. Cases of water were also donated to all residents, by The Michaels Organization.

Victor D. Figueroa mentioned that the Housing Authority is working on a Reopening Plan. He also mentioned that the FDS Reporting is due, as is the 2020 Census.

Victor D, Figueroa, mentioned that the HACC is working on obtaining COVID-19 testing for our residents and staff will be tested before returning to work.

The Housing Authority is working on a disinfecting/cleaning process. There's frequent cleaning of high traffic areas such as the elevators, especially the buttons, door knobs, handrails, and push bars; cleaning of the areas in the lobbies are conducted regularly by the ALP staff, the Security teams, and the Janitorial services. HACC is also currently conducting body temperature checks daily for all residents at the three Senior Towers; the temperatures are recorded and medical action will be taken if a person's temperature has been elevated consecutively for two days.

Visitors to residents at the towers are subject to temperature screenings; non-compliant visitors are barred from entering the buildings. Illness surveillance forms are being completed by visitors upon entering our buildings.

The Housing Authority's website is being periodically updated with information as necessary regarding the Corona Virus Pandemic. The 2020 population Census package is due now, to be completed online.

The Housing Authority continues to keep emergency measures in place as dictated by the Federal State and City Governments. The Governor's 'Stay at Home' order which is included in the Executive Order #107 which is being followed by the Authority; everyone going out into the public it is mandatory to wear mask, and the Authority will be providing masks to the residents at Kennedy Tower.

PUBLIC PARTICIPATION

- Judith Garcia, 3033 Lemuel Ave. Camden, NJ 08105 (Baldwin's Run), had a complaint regarding drug activity in her neighborhood. She stated that her door was kicked in three weeks ago and she reported it. She is very concerned and asking for help because a girl is stalking her daughter. Ms. Garcia has spoken to Mayor Moran regarding this situation. Victor Figueroa has reached out to Captain Pike regarding this matter.
- Laverne Williams, resident of Faison Mews, Park Blvd., Camden, NJ 08103, inquired about Section 8 rent going up. Victor Figueroa explained about non-eviction direction from HUD (talk to Pennrose to request a waiver for any late fees).
 Ms. William's also inquired about public housing construction. Victor Figueroa replied that Michael's Phase IV's construction is continuing and Chuck stated that it's a couple of weeks off because of PSE&G.

Commissioner Polk asked Victor for an overview of the process, what's being done throughout the Authority. Victor mentioned that ALP staff and security staff are checking residents' temperatures daily and everyone entering the towers too, as well as filling out an illness surveillance form upon entering each tower. The Authority is attempting to get residents tested, as well as getting staff tested too before returning to work. Victor also mentioned our disinfecting efforts — security guards, maintenance staff, and some of our resident leaders are helping out. He stated that we are following Executive Orders from Governor Phil Murphy (wearing masks and maintaining 6 ft. social distancing. (The three towers were quarantined because we had a couple residents testing positive in each)

Commissioner Cunningham commended Victor Figueroa and staff for the effort, and outsiders too.

Commissioner Soria-Perez thanked all staff for making sure the residents are safe.

Commissioner Hudson shared the same sentiments, all of Victor Figueroa's staff hard work, for keeping the commissioners updated, for keeping families safe, and for the teamwork.

Commissioner Person-Polk commended Victor Figueroa, staff, and commissioners too.

Victor Figueroa thanked the commissioners, and he also thanked Mike Dugger for his hard work too.
