## EXECUTIVE DIRECTOR'S REPORT

Mr. Figueroa added a few statements that weren't in his Executive Director's Report.

He updated the COVID-19 situation at the Authority. Some staff members have tested positive, and in light of the numbers surging in the State of New Jersey, inclusive of Camden County where it's been considered a hotspot, 400 positive cases in Camden County, the office was closed for regular business. They are still providing the ALP services on a regular schedule. Security guards at the Towers are on their regular schedules and maintenance staff are responding to regular calls. They were responding to emergency calls and continued rehab work in the vacant units. The rest of the staff that can't go to work are teleworking. They're continuing to (INAUDIBLE).

He acknowledged Ronald Spence who took his Nan McKay exam and congratulated him for passing that exam.

He also acknowledged the staff for their hard work and perseverance during these trying times, stating it was difficult not knowing if you're coming to the office or if you're teleworking. He commended the staff for their hard work and perseverance. He further acknowledged the Commissioners for their understanding, guidance, and persistence in these trying times. The support was appreciated and he thanked the Commissioners on behalf of the staff as well.

Resolution 20-55 – Jasmine Kee, Purchasing Specialist. Resolution 20-55 is a resolution authorizing the contract for snow removal services, authorizing an expenditure of funds in an amount not to exceed \$84,000, for a term not to exceed one year with the option to renew the contract for possible two-year extensions, renewed annually and authorizing the Executive Director or his designee to execute documents and to do all things necessary to effectuate the transaction.

Commissioner Person-Polk asked if there were any questions from the commissioners.

(a) Commissioner Miller asked what last year's not to exceed amount was. Last year's not to exceed was \$59,211.23. Also asked for an explanation of why they are in the situation where they are having a contract that far exceeds the not to exceed amount

that was approved last year at this late date. As discussed in closed session, this type of service was solicited in the one and half years since I've been in this position as well as the prior purchasing manager. This service is tough. So I don't think any fault, again, we were under contract last year there was no fault to the agency. What we do have planned, as mentioned, is to do both, snow removal services and landscaping, so we think that will turn things around. It wasn't any fault to the agency. He stated that he didn't indicate that there was a problem with the agency. His concern was with the timing. He asked combining services will be done when, in the early spring? I don't have a date when we will put that solicitation out, but I can provide you that information once we have it. He suggested that it's done sooner than later, especially if looking to combine services over a 12-month period. Also suggested talking to the city or any other public or county entity that it is in the City of Camden and seeing if they can go into the economies of scale with a joint purchasing contract. Ms. Kee stated Thank you. I'll take note of it.
