Mr. Figueroa added a few statements that weren't in his Executive Director's Report. He listed several grants that they have their eyes on:

Safety & Security Grant (federal HUD grant) in the past allowed for cameras for Mickle Tower and Westfield Tower. They're focusing on Kennedy Tower and hope to apply and get awarded that grant. Based on a HUD lottery.

Foster Youth – Section 8 program and res initiatives – applying

Main Stream grant – supportive services – applying

CNI grant – Ablett Village & Crammer Hill area. Working on application by mid-December. John Walshek was secured as grant writer with long track record. Hoping to be successful in this grant by HUD.

Youth Build grant – the FOA, the funding availability from the DOL. Due in September, but not announced yet. Keeping an eye on that.

Annual and Five-Year Plan submitted last October, but due to pandemic, an extension was given, so revisions are being prepared. It is due in January. Should have a presentation for the Board of Commissioners in December's meeting. Then a 45-day public notice period with the revisions. Asset Management Department is working on that.

Budget 2021 is being prepared. So BDO, Dwayne Tucker, the Interim Finance Director, is preparing the spreadsheets and giving to staff for recommendations so a budget for the Board of Commissioners can be made for the next board meeting.

We were recently approved by HUD for the RAD Portfolio application that was submitted. Intending to RAD all <u>amps</u> currently under portfolio, received the CHAPS awards and had a kickoff meeting with HUD and making those transfers and transactions.

Mentioned that COVID-19 is surging. Pennsylvania with 14 days in a row with over 1,000 positive cases reported. New Jersey is not far behind. May need to close business offices and do teleworking again. Following the guidance of the governor/mayor. Had 4 positive cases of staff, let alone residents, for a total of like 16 folks who have tested positive. Business offices were closed the last week due to developing cases; 30 people were tested, and 1 person positive was quarantined. Don't want to keep opening and closing causing disruption. May close longer next time. Everyone must wear a mask. Signs posted that nose and mouth must be covered. Social distancing, washing of hands. Health professionals are scared of what's going on right now and very concerned about the second wave or third wave.

Mentioned Reba V. Hicks celebrated 29-year anniversary working at the Housing Authority last Friday and congratulated her (followed by congrats from others).

Congratulated Martin Maxwell – celebrated 45 years at the Authority and recently retired after 45 years.

Congratulated Ronald Spence, Assistant Manager, for passing the Nan McKay Housing Choice Voucher in Public Housing Rent Calculation Certification Exam (followed by congrats from others).

Commissioner Person-Polk made a statement thanking Victor and his staff for being on top of things during COVID and stated that they have done a wonderful job, knowing that it's hard with the opening and the closing. Also stated he was correct to close in light of what was going on because it would slow the pandemic down. Also stated he, the residents, and his staff need to be commended for being very conscientious of that.

Victor D. Figueroa thanks Commissioner Person-Polk on behalf of his staff for her support and the Commissioners' support and guidance. He stated that they're going to keep an eye on it, they don't take it lightly, and it's a serious situation. He stated some folks don't like wearing masks; but they're wearing masks there and making sure everyone does.

Commissioner Person-Polk stated that Victor moved quickly when he found out about the positive testing, and he did an excellent job. She wanted to say it publicly and for it to be on the record.
