Cynthia Jordan-Hannah:

Cynthia Jordan-Hannah, 82 Grand Street, Camden, NJ - are you looking into my husband being put on her lease; Resident Initiatives have worked very hard and diligently with me and my family; what is the Authority and Michael's Development going to do about the air conditioner problem and the heating problem? When they built the units they did not build any piping to go upstairs in the summer we have to put in a portable air conditioner in the window and in the

winter we are cold. We have a very high utility bill. We need the problems that is currently present to be rectified. I need heat and air conditioning.

Diana Duran:

Diana Duran, 154 Randolph Street, Camden, NJ—came in four years ago with issues to my unit, nothing was done; living in an uninhabitable unit for seven and a half years, no air condition, no electric, has carbon monoxide leaks in the unit, daughter was hospitalized various times and nothing is being done. A city inspector came out from the Court and the duct system is alleged to be illegally done; one side of her property has water damage underneath the unit and the water collects; the windows have been discontinued but residents are still living in the units with discontinued windows. Documents were falsified in court and she is forced to move to a unit that I have not seen and is the right size for my family. What is HACC going to do about these continuing problems...

Laverne Williams:

Laverne Williams, 1655 Park Boulevard, Camden, NJ – the units coming back to Branch Village, you said it was 58 one bedrooms in Phase 4; Which one of the Branch Village units have the single family one bedroom units. Who submitted the application to apply for money for these houses, the ones that are being built now? Is the money for the houses already in place? Ms. Williams expressed her concerns for the residents of McGuire Gardens and their suffering with their no air conditioning and high utility bills...request copy of ED's report. Want available staff to answer questions.

Victor D. Figueroa:

Asked Ms. Williams to specify which house she is referring to, if it was Branch Village low rise.

Magda Polanco:

Magda Polanco, I've been living in Liberty Park for nine years and she expressed her gratitude to Ella Baker for working diligently with the residents. I have a rug near my unit that is causing my son to have fungus on his toes, we have bedbug in the unit, management promised to come and exterminate but no one came to exterminate because they cancelled the appointment; a dead tree in front of the property that is leaning towards her window;

Victor D. Figueroa:

Explained that Liberty Park is not one of the Housing Authority sites, this is a project based site that we are working with the owner and we will follow-up with them about your concerns.

Commissioner Person-Polk:

Asked Ella Baker to get all the complaints for Liberty Park properties and rely them to Mr. Victor.

Sondra Wiles:

Sondra Wiles, lives in Liberty Park, I am angry at the conditions at where I live. I am being evicted. I fought the Health Department for my area and for work to be done on my apartment. I went above and beyond using my own money for repairs and I am being evicted because of it. I am fighting because of this. Ella Baker gives us programs to help us to desensitize our anger. Ms. Baker gives us food and water because the water is bad. Management told me to move from my unit to another unit so they can do work. I have sixty days to move and I have nowhere to go. I've been to eviction Court three times and the matters were dismissed. Who do we call when our problems escalate... the management office dismisses us and yell at us and speak to us like children. Liberty Park is a very bad site and I am angry with the situations and living conditions. Who and where can I get help? Can I get business cards that I can call someone every time nothing is being done?
