### PUBLIC PARTICIPATION

Laverne Williams: 1655 Park Boulevard, Camden, NJ. Regarding the Choice Neighborhood units and Branch Village, I received a letter from Mr. Figueroa, stating to about the Return/Come Back to Branch Village, first choice is phase 4, one of the 38-1 Bedroom units and second choice is Phase II? Do I have to do phase II or do I just choose any unit number location I like? She expressed that she did not like the layout of the new homes being built at Branch Village, she said she was attacked previously when she first lived at Branch Village and with the new layout there will still be someone living either on top or on the bottom of her. Ms. Williams said the tenants do not know what is going on in their community and would like to be kept updated. Victor D. Figueroa: Responded to Ms. Williams, telling her that the Board will respond to her question in writing. Commissioner Keys Frazier; Explained to Ms. Williams that the buildings were old but the new buildings are being built with a sound barrier and further explained that there have been no complaints from residents of Branch Village Lowrise regarding the noise levels. Maynard Hall: 202 Raritan Street, McGuire Gardens, Camden, NJ. Can residents have a newsletter to let them know what is going on in the community and what are the projects that HACC is working on. There's a senior who lives near/on Jones Street (correct physical address unknown) has a hole in her floor and there is a rug over it and she is in a wheel chair. How can we make it better, whether it's jobs, homes or the community let's work together to make it better. Commissioner Keys Frazier: Asked Maynard Hall to give the address of the senior she referred to that is in the wheel chair to the property manager at McGuire. So that this matter can be immediately addressed before the senior gets hurt.

Vivian Smith:

1318 Lemuel Avenue, Camden, NJ. (Baldwin's Run) – her unit is unsafe, neighborhood unsafe, kids cannot go outside to play kids and are in danger due to drug usage in front of the property, loud music all night; was being harassed by a HACC maintenance person; the property manager moved her to a new location, but the floors were not stripped, walls not painted; unsafe living conditions.

Asked that Ms. Smith's unit be rehabbed as soon as possible.

Wanda Riley:

Stated that she and Ms. Smith have been speaking about the problems in her unit. Ms. Riley said she with call Tyrekia Bradley and will set up a meeting with Ms. Smith for Tuesday for inspections and address all her issues.
