Resolution 21-38 – Dwayne Tucker, Finance Director. Resolution 21-38 is a resolution adopting our budget for the year ending December 31, 2020. This is the prior fiscal year with revenues of \$25,892,691.00.

Commissioner Person-Polk asked if there were any questions from the commissioners.

(a) Commissioner Miller asked for an explanation of doing this resolution after submitting the 2021 budget. Mr. Tucker stated budget has to be introduced to the Board and then sent to the Department of Community Affairs and it cannot be adopted until it's gone through and approved or any additional information and changes are given. 2020 budget needed to be approved and adopted prior to 2021 budget. DCA stated they hadn't received it when in fact they had. Commissioner Miller questioned DCA notifying HACC of submissions received. Mr. Tucker confirmed they do not give notification of received submissions. They were told to submit 2021 and gave notice that they had received the 2020 and wanted the budget to be adopted. Commissioner Miller suggested that a policy procedure moving forward be implemented to follow-up and confirm DCA's receipt of submissions. Mr. Tucker agreed.

Resolution 21-39 – John Kostyal, Human Resources Manager. Resolution 21-39 is for approving and adopting a Teleworking Policy for the Housing Authority of the City of Camden and authorizing the Executive Director or his designee to do all things necessary to effectuate the transaction. Whereas the Housing Authority has drafted a proposed Teleworking Policy for the Housing Authority, and whereas the Housing Authority Teleworking Policy was created in response to the coronavirus pandemic whereby its safety mechanisms for the Housing Authority staff who at times are required to work remotely because of the COVID-19 restrictions and to ensure the daily work duties of those employees continue on a daily basis. Whereas the Housing Authority Teleworking Policy has been reviewed and approved by the Executive Office and includes descriptions in all divisions, roles and responsibilities, types of telework, modifications to telework and employee teleworking agreement which all employees will need to comply. And whereas the Housing Authority Teleworking Policy is consistent with State and Federal COVID-19 guidelines and Housing Authority policies and procedures to ensure the safety and well-being of employees, residents, and visitors of the Housing Authority.

Commissioner Person-Polk asked if there were any questions from the commissioners.

(a) Commissioner Miller asked if the policy was reviewed by in-house or outside labor counsel. Mr. Kostyal stated it was reviewed by all in-house staff attorneys and general counsel. He also stated labor counsel is used for labor matters involving arbitration. Commissioner Miller is concerned about labor issues with policy moving forward. Mr. Kostyal stated that the policy is founded within the Teleworking Policy that HUD uses. Commissioner Miller stated his concern over past litigation by current and past employees and hopes labor attorneys review this to indemnify HACC as much as possible. Commissioner Person-Polk stated it would be reviewed by outside counsel.

PUBLIC PARTICIPATION

Commissioner Person-Polk stated that they were now in Public Participation and stated Mr. Figueroa would be unmuting everyone.

Laverne Williams, 1655 Park Boulevard, Camden, NJ 08103. Ms. Williams asked for an explanation about the contract for PSE&G.

Ms. Riley stated that it's a contract between PSE&G and the Housing Authority, and it's an energy conservation program where PSE&G is replacing all equipment with energy-efficient upgrades.

Ms. Williams asked if it was for Section 8 properties.

Ms. Riley stated it was the three senior towers, the Success Learning Academy, and Baldwin's Run Community Center.

Ms. Williams stated the PSE&G rates are ridiculous and needs an increase from HUD to help pay gas and electric.

Commissioner Quiñones asked how much more is the increase and since when?

Ms. Williams stated since March and April her bills have increased to \$150.00 a month.

Commissioner Person-Polk asked if she had a washer and dryer.

Ms. Williams stated that was separate, but she needs more assistance from HUD.

Commissioner Quiñones agreed and stated he was glad she brought it to their attention.

Commissioner Person-Polk stated they were based on Faison Mews and doesn't come under the Housing Authority.

Ms. Williams stated she was Section 8 and it does.

Mr. Figueroa stated they would look into it.

Ms. Williams asked if the grant money was for Ablett Village. She asked for an explanation of the 120 units when they're building 25 to 50.

Mr. Figueroa stated that the time was up and they already responded to Ms. Lavern's questions.

Commissioner Person-Polk stated time was up and Chuck Valentine would answer the question.

Mr. Valentine stated they're building 422 units and there's 306 units there. The 25 to 50 were home ownership.

Ms. Williams asked about the rehab.

Mr. Valentine stated they were doing 120 rehab of existing home ownership units but 420 rental units.

Commissioner Person-Polk asked Commissioner Quiñones if he would like to speak.

Commissioner Quiñones questioned Mr. Valentine's statement about the 120 home ownership.

Mr. Valentine stated they were doing 25 to 50 home ownership units for sale and then existing 120 homeownership units that will be helping existing homeowners do renovations at Cramer Hill.

Commissioner Person-Polk asked Commissioner Quinones if he had any other questions.

Commissioner Person-Polk asked if there were any other questions and asked if Mr. Figueroa had anything he would like to say.
