#### **NEW BUSINESS**

Ms. Johnson-Williams stated the Resident Initiatives Department under the CNI Program participated in a panel discussion at the CHOICE MEANS CHOICE Urban Strategies 2022 Conference in Fort Myers it was on November 29, 2022 to December 2, 2022. She provided a copy of the PowerPoint and the program for the Commissioners to review. The topic on the panel was People: It's a Marriage.

She also stated that Commissioner Dansbury verbally stated that he had a conflict with HACC in that he owns a property that the tenants are functioning with the Section 8 assistance through HACC. She stated that in the last meeting Commissioner Dansbury recused himself from voting on certain checks that were written to him, and he only voted on the payment register. She wanted it on the record that Commissioner Dansbury put the information in writing to the Chair of the Commission and explained how it came to his attention. She stated the statute that governs the HACC, 40A:12A-17, requires that a statement be made on the record to the Commissioner to the Authority in writing and steps were taken to correct it which meant that payments would come from either HUD or the Department of Community Affairs and not HACC. She wanted the record and the minutes to reflect that information.
